This session will take place between 3-3.45pm and will look at the opportunities and challenges in the changing real estate market, where a two-tier market is emerging in many sectors.

Using the Marks & Spencer planning controversy as a case study, the group will examine whether buildings should be demolished and rebuilt, or retrofitted to make them more efficient. The panel will answer key questions such as how we can reuse existing buildings most effectively and how recent planning challenges impact viability and deliverability.
