The new **Procurement Bill** is here. Whether or not it offers wholesale reform is yet to be determined. As we have already seen, it will need to be amended. But with the committee stage not starting until 4 July we don't have a settled position yet.

- meet new obligations
- deliver value for money;
- maximise public benefit;
- share information clearly and concisely; and
- act and be seen to act with integrity.
